I.THE FOLLOWING CONDITIONS OF PWD STIPULATED IN CHIEF ENGINEER, WRD, CHENNAI REGION, CHEPAUK, CHENNAI-5, LETTER NO: T5(3)/ Sr.D.O/19519/2006/ DT.13.11.2007. ARE TO BE COMPLIED BY THE APPLICANT BEFORE ISSUING OF THE LAYOUT APPROVAL BY THE COMPETENT AUTHORITY (LOCAL BODY)

(1) THE WIDTH OF THE FIELD CHANNEL NOTED IN THE SKETCH SHOULD BE MAINTAINED AS PER THE REVENUE RECORDS. NO ENCROACHMENT OR OBSTRUCTIONS FOR THE FREE FLOW OF WATER SHOULD BE MADE.

(2) THERE SHOULD NOT BE ANY OTHER CROSS MASONRY WORKS CARRIED OUT BY THE PROMOTER IN THE CHANNEL EXCEPT THE PERMITTED NUMBER OF CULVERTS REQUESTED BY THE APPLICANT.

(3) THE APPLICANT SHOULD CONSTRUCT TWO CULVERT IN SURVEY NOS. 124 AND 96 FOR ACCESS ACROSS THE FIELD CHANNEL AT THE PLACES SHOWN IN THE SKETCH ENCLOSED. THE WIDTH OF CULVERT SHOULD NOT EXCEED 8.30M. THE PROPOSED CULVERT SHOULD BE MADE OF RCC BOX TYPE WITH A VENT OPENING OF 4M AND ADEQUATE LENGTH DEPENDING UPON THE EXISTING SITE CONDITIONS.
